### *Facility Charge Adjustment*

For many years now we have found ways to absorb the fluctuations in wholesale power cost. Many aspects of the membership demographics constantly change, and we have to find ways to adapt. With the passage of time and the ever-changing dynamics of our membership, the board directed a study of our rates to determine if changes were needed. In August, we received the results. Good news is in most cases the Kwh charge was reduced. While the cost per Kwh was reduced it was necessary to increase the monthly facility charge. Overall, the average monthly bill will increase by 1.77% beginning November 1, 2021. The last rate adjustment was in 2009, twelve years ago.
